Information from the *Constitution and Bylaws* and *Standing Rules and Procedures*

Who has a vote at National Conventions?

- Each National Officer, specified in Article II, Section 1. [*National President and six Vice Presidents*] in attendance at convention
- Each officer of the Fraternity, specified in Article II, Section 5. [*Alumnae Chapter Specialists, Area Collegiate Directors, Area Collegiate Specialists, National Academic Excellence Chairwoman, National Alumnae Chapter Chairwoman, National Alumnae Chapter Enrichment Specialist, National Alumnae Chapter Extension Specialist, National Alumnae Communications Chairwoman, National Alumnae Coordinator, National Alumnae Engagement Chairwoman, National Assessment and Evaluation Chairwoman, National Collegiate Enrichment Coordinator, National Collegiate Finance Coordinator, National Collegiate Housing Coordinator, National Collegiate Membership Coordinator, National Collegiate Operations Coordinator, National Diversity, Equity and Inclusion Chairwoman, National Extension Chairwoman, National Harm Reduction and Prevention Chairwoman, National Historian, National Honor Policy Coordinator, National Housing Chairwoman, National Leadership and Curriculum Development Coordinator, National Leadership and Special Projects Chairwoman, National Member Development Chairwoman, National Music Chairwoman, National Panhellenic Coordinator, National Philanthropy Coordinator, National Phi Mu Officer Academy Chairwoman, National Provisional Member Education Chairwoman, National Ritual Coordinator and the National Volunteer Experience Chairwoman*] (except those appointed under Article II, Section 5.A.33.) in attendance at convention
- One official Delegate (or Alternate Delegate, in the absence of the official Delegate), from each collegiate chapter and each nationally recognized alumnae chapter in attendance at convention
- Each Past National President in attendance at convention
- Each Trustee of the Phi Mu Foundation in attendance at convention

How is a chapter Delegate eligible to vote?

In order to have its Delegate entitled to vote at a National Convention, each collegiate and each alumnae chapter shall have met all National Obligations, including fees, fines, dues, assessments, reports or special requirements at least twenty-one (21) days before convention. Delegates shall be in residence at convention headquarters [the official convention hotel], in attendance for the entire period of the convention and present at all scheduled sessions.

Collegiate Chapter Delegates

The President of the collegiate chapter shall serve as Delegate to the National Convention. An Alternate Delegate shall be elected by the chapter from the chapter Executive Committee. Chapters on probation with the Fraternity at the time of national convention will not be granted voice or vote.

Alumnae Chapter Delegates

Any alumna member in good standing may be elected to represent her alumnae chapter as Convention Delegate. An Alternate Delegate may be elected by the chapter. The alumna must have paid Forever Faithful dues and local dues to the chapter to serve as Delegate.
